

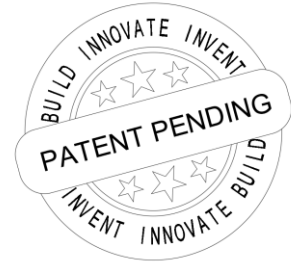

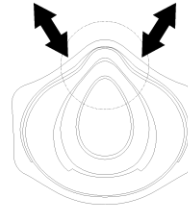

When the product is taken out of its package, the active form compatible with every 3D face takes a conical shape. Activ form Automatically fit to the face, Headband made by two elastic straps, between the filter material and sealed soft inner pad on nose, Exhalation valve provides lower exhalation resistance and low levels of CO₂ and moisture in the mask, NR non reusable = single use,

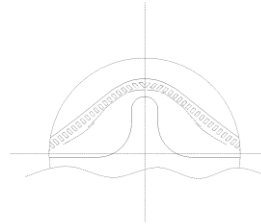

Fine dust, fumes, water and oil based mists/aerosols in areas up to 4 x OEL (Occupational Exposure Limit)

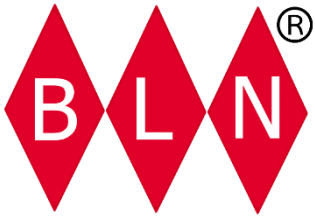
Areas of Use

Applications

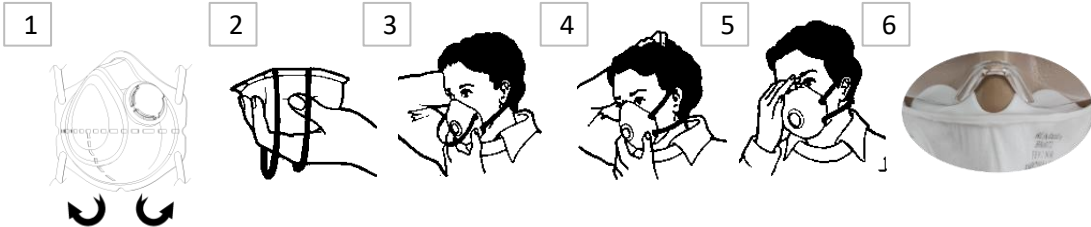

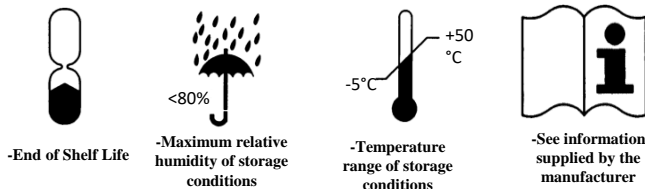
PRODUCT CODE: NBM 02 FFP1 NR Instructions For Use

The user has to be trained and instructed in wearing the mask.

- FFP masks do not protect against gases and vapours.
- The oxygen concentration of the ambient atmosphere should be at 19,5 % Volume.
- These respirators may not be used if the concentration type, and properties of contaminants in the ambient atmosphere are unknown or at dangerous levels.
- Respirators should be disposed if damaged, if the breathing resistance becomes high due to clogging, or at the end of a shift.
- Never tamper with, alter or modify the respirator.



1. After unpacking the mask, let's turn it into a 3D shape as shown in Figure 1.
2. Hold the facepiece with the external convex part on your palm and the elastic straps under your hand hold the breathing apparatus as shown in figure 2.
3. Position the facepiece under your chin with the nosepiece upwards.
4. Position the lower elastic strap under your ears and the upper one on the top of your head. Check the facepiece seal before entering the working area through the test for leaktightness by breathing in and out deeply (in models equipped with an exhalation valve, close the valve with your palm). In case of detection of escapes of air, reposition the mask
5. When using with glasses, changing the nosepiece as in figure 6 prevents steam in the glasses.
